MEMORANDUM OF UNDERSTANDING

Between

&
Government Degree College, Avanigadda



1. Parties :-

This Memorandum of Understanding (hereinafter referred to as "MOU") is made and entered into by and between

- a) Department of Computer Science, Sri ABR Government Degree College, Repalle, Bapatla District
- And
- b) Department of Computer Science, Government Degree College, Avanigadda, Krishna District

2. Purpose :

3. Term of MOU :

4. Responsibilities of Parties :

- The faculty and students of Party 1 will teach/train the faculty and students of Party 2, so as to enrich the teaching experience of faculty and learning experience of students of the Party 2 as per the schedule resolved in the meeting held on 31-03-2022 in the Chamber of the Principal, Sri ABR Government Degree College, Repalle.
- The Party 2 may request some of the faculty or students of Party 1 to address the faculty or students of Party 2.
- Mere participation of faculty and students of Party 1 in teaching the faculty and students of Party 2 according to this MOU does not carry any right or any legal entitlement to demand for placement with Party 2.
- The Colleges shall entrust a faculty member in their respective colleges to liaison between the parties.

5. Signatures :




