- 2. The parties will not disclose or use any confidential information for any purpose other than that for which it was disclosed, without the written consent of the disclosing party.

## Dispute Resolution:

- 1. Any disputes arising out of or in connection with this MOU will be resolved amicably by negotiation between the parties.
- 2. If the parties are unable to resolve the dispute through negotiation, they will attempt to sett-le it through mediation, with a mediator appointed by mutual agreement.
- 3. If mediation is unsuccessful, the dispute will be resolved through arbitration, with a single arbitrator appointed by mutual agreement.
